

## 2011 Community Planning and Development Resources - As Amended

Resources available for implementing the City's Consolidated Plan come primarily from three entitlement programs: the Community Development Block Grant (CDBG), the HOME Investment Partnership Program and the Emergency Shelter Grant (ESG) programs. These programs are managed through the Community Planning and Development (CPD) Division of the U.S. Department of Housing and Urban Development. Compared to the 2010 allocation amounts the City received for these programs, the 2011 allocations represented a \$1,357,514 decrease to the City.

The Amended 2011 Action Plan describes the City's actual entitlements, reprogrammed prior year funds, projected program income and the activities that entitlement dollars will fund, enabling the City to make progress toward meeting the goals of 2011-2015 Consolidated Plan.

### 2011 Amended CDBG Program

The 2011 CDBG allocation is a 17% decrease from the 2010 allocation. As stated above, the \$1,056,906 reprogramming from prior year funding made the decreased the CDBG original plan amount from \$8,111,180 to \$7,074,281 in the amended plan, a decrease of \$1,036,899. The changes to the funding levels of different activities are detailed in the cost summaries (italicized) and project descriptions on the following pages.

### 2011 Amended HOME Program

The City's HOME program received a decrease to its 2010 HOME entitlement. For 2011, the City originally projected for level funding. Instead, the actual 2011 HOME award was a decrease of 12% (\$230,648 less than the 2011 grant). With the prior year reprogrammed activities the HOME program will fund five additional projects.

### 2011 Amended ESG Program

The City assumed that the final approved appropriation would result in level funding for the 2010 ESG grant amount. Instead, the City only received a .2 % increase (\$626 more than the 2010 grant amount) to the initial grant allocation. The impact of this increase will be minimal for those programs supported with City ESG funds.
